**NIMS ICS and resource management (Old NIMS for the Fire Service) (NIMS ICS)** (*All classes start at 0800*) Class Fee: \$85 in-county, \$100 out-county

- Mundy Twp Station 2, Sat. December 9, and Sun., December 10. When registering in SMOKE, utilize the class under Course ending in 0011.

**Hazardous Materials Operations (HazMat)** (*All classes start at 0800*) Class Fee: \$125 in-county, \$150 out-county (The OFFT no longer offers HazMat Awareness)

- Mundy Twp Station 2, Sat., March 3, Sun., March 4 and Sat., March 10. When registering in SMOKE, utilize the class under Course ending in 0011.
