RETURN BY SEPT 18, 2017 (or earlier)

SPECIAL NOTE: There will be a required registration class held on Monday, Sept. 25, starting at 1800 (PM) at Mundy #2 OR Tuesday, Sept. 26, starting at 0900 (AM) at Swartz Creek #1. Students should bring a laptop or tablet with internet accessible to this class to fully participate. To effectively work, only one device shall be used to check your email and Resource One (R1) at the same time. This is to register the students on line through R1 and explain their requirements. The Fire Academy uses an on line based interactive curriculum to do pre-class attendance quizzes and test through R1, an IFSTA funded web site. This does NOT replace the class room lecture and practical sessions.

Firefighter Academy (FF I/II) – Classes begins October 2/3, 2017

- Mundy Township #2 (Nights) – Monday, October 2 at 1800 hours (Mon. & Wed.)
 Swartz Creek Area #1 (Days) – Tuesday, October 3 at 0900 hours (Tues. & Fri.)

There will be some weekend classes. - A syllabus will be provided.

Academy cost per student: \$250.00 in county; \$800.00 out of county (not a member of the GCAFC)

Fees paid for Fire Academy classes will be refunded, minus the cost of the student text book, if the student drops out before October 30, 2017. Classes associated with the academy include Driver Training, Basic First Aid/CPR, Clandestine Lab, Hazardous Materials and Incident Command System and Resource Management for the Fire Service. Students enrolled in the academy DO NOT need to send a separate enroll form for these associated courses. Students will be required to register for the academy class and ALL the associated classes through System Maintenance of Knowledge and Education (SMOKE).

Class fees include all academy courses listed above and 2 adult student tickets for the graduation dinner.

- Paid for by Student - All fees must be paid for in advance if student is making payment.

Please DO NOT send class fees with registration. An invoice will be sent to each department.
